The member may request changes to the final guest count until the Wednesday prior to their event date. Any changes made after this period may not be accommodated or may incur additional charges, subject to Lakeshore Sport & Fitness's discretion.

All guests must complete guest waivers prior to attending my hosted event must sign in their cars with make, model and license plate number. If not completed, the guest will not be able to attend.

In the event of sickness, I will notify LSF 10 hours prior to the start time of the party. The party can be rescheduled to a future available date. Cancellations within five business days will be charged for the full cost of the party, based on the estimated number of guests provided.

Outside food and drinks are prohibited.

Any accidents resulting in pool closure will result in an additional charge of \$150. Children under 5 who are not able to swim independently must have an adult in the water with them (this does not include the LSF Host).

Costs are subject to change if LSF is called upon by the party host to provide additional staffing, set-up, space, and/or equipment.
